Autonomy Zonal Forum Minutes May 1, 2012 World Service Conference

Meeting opened 7:45 pm. Present: Etta, Craig, David, Rob, Leon, Sherry, Walt, Eddie, Donna Lee, Allen, Merle, Zoe, Paula, Cheryl, Rob, Debbie, Rochelle

Serenity Prayer. Introductions around the table. Allen said he would send the spreadsheet with the results of the motions, resolutions, and proposals business session. It will be forwarded to the Zonal Forum.

- We discussed the need for change. C&P is working with Mountaineer to bridge the gap meetings. It may be prudent to discuss combining and coordinating services/resources amongst the regions.
- It was suggested we discuss how we can change the role of the Zonal Forum.
- Since we only meet two times a year, it might be helpful to have a work group or an ad hoc committee.
- There may be changes as a result of geographical boundaries, such as a PA region, where the four regions become a state unit.
- Communication is limited due to the infrequent Zonal Forum meetings. We may need to address ways to better communicate with greater frequency.
- There may be more specific guidelines for moving forward in the service system at the next WSC. Is there a way to keep a little of what we have, and change a little of what we have.
- What are the things the Zonal can do, which a region cannot do? i.e. Zonal meeting list information.
- This is the place we can network so we can share ideas, and not be alone.

- One region questions why they are a part of the Autonomy Zonal Forum, rather than another Zonal.
- Scanning and planning, then informing.
- Inviting people, through sponsorship, friends, home groups to the Zonal Forums
- Have a GSU model presented at the zonal forum, including exposure to the terminology
- The Zonal needs to be supported by the regions. We need direction from the regions as to the direction they want us to go.
- The Zonal Forum is the first place members who are not involved in service can be exposed to a level of service and meet people at this level of service
- We may consider presenting information to the local community as our first function
- It was suggested that rather than using the zonal as an educational function, we have other regions carry votes
- Votes shared with other states.
- It may work well during the transitional time, which is the next level of service
- When we have a conversation and meet as a Zonal, we need to have only the delegates speak to the topic. We only meet two times a year, for 6 hours
- Can we agree in principle that we limit our discussion to delegates, alternates, and former delegates at the Zonal forums?
- It is not fair to be exclusive to others to ask them not to participate. We can put other items into a "parking lot" to be discussed if there is time.
- We could consider setting a time limit to each part of our agenda
- The only time over the years it has been problematic is when it is a conference year. We can have some guidelines in place to keep it on topic.
