## Regional Reports:

### **Central Atlantic**

Hello family,

The Central Atlantic Region consists of 17 areas holding 589 meetings throughout Virginia, and small portions of West Virginia, Maryland, Pennsylvania, and North Carolina. On June 20-22, 2014 ECCNA 18 (East Coast Convention of Narcotics Anonymous) was held at the College of William and Mary in Williamsburg, VA. The event was hosted jointly by five Central Atlantic Areas; (New Dominion, Richmond, Beach, Peninsula and Tri-Cities). All proceeds from the convention are used to purchase Basic Texts which are donated directly to the regional service bodies within its participating states, to be distributed to jails & prisons throughout the east coast. We look forward to being able to report the exact number of basic texts "raised" at ECCNA 18 in our next report in January. Preliminary estimates place the

potential number between 4,000 to 5,000. To learn more about the ECCNA, what it considers "participating" states & regions, its history, and so on visit <a href="www.eccna.org">www.eccna.org</a>.
On July 18-20, 2014 BRANA 33 (Blue Ridge Area of Narcotics Anonymous) was held at Natural Chimneys Campground in Mt. Solon, VA. First held in 1982, the <a href="BRANA Campout">BRANA Campout</a> is the oldest major Narcotics Anonymous event in Virginia. Despite the rainy weather over 450 registrants attended the event. The Blue Ridge Area of Narcotics Anonymous has a dozen home groups and 30 meetings a week in Harrisonburg, Staunton, Waynesboro, Fishersville, Luray, Mount Jackson, New Market and Lexington.

Our PR Subcommittee recently participated at the 12<sup>th</sup> Annual Virginia Summer Institute for Addiction Studies in Williamsburg, VA July 14-16, 2014. This is an annual health fair & conference focused on addiction treatment which our Region has been invited to participate in for guite a few years. Our participation consists primarily of an information booth manned by NA members who volunteer their time answering questions to anyone interested in learning more about the life saving message of Narcotics Anonymous. Our GSR Assembly on April 19th, 2014 in Fredericksburg, VA was a great success. This annual event provides an opportunity for Regional trusted servants to report on the events of the past year, and for our Delegate Team to glean the region's conscience regarding the various elements of the CAR/CAT prior to the WSC. 61 representatives carried the conscience of their group at the Central Atlantic's annual assembly.

Our H&I Subcommittee is finalizing efforts to create a policy for members throughout the region to assist incarcerated addicts in writing the steps. EPARNA collaborated over the winter with GPRNA to hold the second of two joint CAR workshops in the Montco Area. Buck County Area is planning a convention for January 2015, and they are holding a variety of fundraisers in conjunction with that event.

## **Mountaineer Region:**

Greetings from the Mountaineer Region of NA! The Mountaineer Region currently supports 11 Areas with 159 meetings in West Virginia, Ohio, Maryland, Kentucky, and Virginia. We have one new Area around Morgantown, WV that resulted from a split from two adjacent Areas. We also have one Area in Southern West Virginia that is struggling to keep the doors open. There are several committed members who are working with this Area and we have had several discussions at the Regional level regarding committing to building an outreach subcommittee in order to better assist the very rural areas of our Region. We continue to carry a strong NA message throughout the Region. At our Spring Mountaineer Regional Service Forum, held during our Spring Convention, we reviewed the decisions from the World Service Conference and the forum was well attended.

Our phoneline is functioning very well; we are using One Box answering service to send every call directly to a recovering addict's cell phone. Phoneline members are on a 4 hour rolling weekly schedule and this continues to work out great. We are averaging about 200 calls per month with approximately 50 volunteers answering direct calls. We also have nearly 100 volunteers as contacts in their Areas. Our phoneline chair has been busy doing workshops across the Region and we are constantly having new members signing up to be of service.

Our H&I commitments have remained steady with our Areas currently hosting 22 H&I commitments across West Virginia and Southeastern Ohio . We continue to inventory how H&I on a Regional level can support these current commitments. Our new H&I Chair has worked to compile a list of all local, regional, and federal facilities, including juvenile facilities in our Region. Please let us know if the Zone is interested in this information.

Our PR efforts continue to grow as well as we coordinate utilizing our Regional display at events around the Region. The Metro Valley Area in Charleston, WV and the Greater than Ourselves Area in Huntington, WV has added 30 more signs in the local public transit buses across the cities since we last me. Our Regional Billboard also continues to make an impression in the community. Several Areas have worked to get our Basic Text in the libraries as well. We have been working hard to make sure that NAWS has our most up-to-date meeting information for their meeting locator. We also have several flyer days scheduled in a few of our Areas as well.

The Mountaineer Region hosts two conventions annually; one in the Spring and one in the Fall. The Fall Convention this year will be held on October 31-November 2, 2014 at Cedar Lakes in Ripley, WV. The convention is held in a beautiful outdoor environment with 3 lakes, a lodge, and other multiple buildings with dorm style and hotel style rooms. Our Region hosts the Mountaineer Regional Service Forum at every convention in order to present and discuss service related issues. This Fall the forum topic will focus on what our Delegate Team learns from the upcoming Multi-Zonal Service Symposium to be held in September in St. Louis. MO.

Christina: Opened the meeting with a moment of silence followed by the Serenity

Prayer at 11:26am. Christina: Introductions Kim: Read 12 Traditions Barbara: Read 12 Concepts

Reports were not read to conserve time. Hard copies to be given to Merle to put in minutes.

<u>Website</u>: Kim & Sherry working on website. Gave presentations.

- Option A: Clickable color map for different regions. Linked to regions. Zonal to region to area
- Option B: Clickable map. Click on region to go to their website
- Option C: Goes directly to map and region

Kim: Current CMS (content management system) is limited. Redesign maybe to WordPress. Thinks this might be best. Thinks website should be cohesive. Stated we need to make a decision today on hosting to keep Autonomy Zonal Forum.org Sherry: Presented her design ideas. Geographic design very important for people to know where we are. Says CARNA only talked about hosting, not domain. A slightly different version of Kim's presentation. Can go through clickable text and maps. Links of a lot of NA related material. Thinks WordPress can incorporate this. Noted map can accommodate our out of country addicts. Zone to Region to Area to Groups are main things to help addicts find a meeting. Presented a map with less clicks to navigate. Questions this may be same option as "C". Map is a little more detailed. Kim: She can incorporate these things also. Why can't we work together on website? Says CMS is not compatable. Do we want to move the website to a new host? How can we not have a host? Domain name carries the host. Sherry: thinks maybe there's a conflict with Kim hosting website. Said CARNA

thinks the same.

Christina: Asked about the \$7. Plus change to host paid by each region.

Sherry: Asked if Kim charged to host.

Zoe: What are the duties required for hosting?

Kim: Just a storage place for the files. No host duties. Host maintains the server. Host keeps problems at bay.

Merle: CARNA said it was a conflict of interest. Please explain how it was a conflict of interest.

Eddie: Recollects that is was nothing deep, just not to muddy the waters, like no contracts, nothing personal, some felt stronger, some wondered what's the deal.

Steve: C&P region has not made a decision on who's doing what. Doesn't understand. More important things in NA.

Christina: We do need to make a decision. Asked Sherry if there is a problem that Kim is not charging. Problems have to go to Kim instead of an outside service. We can change hosts.

Kim: CARNA got hijacked. Thinks this happened because there is not a person to contact for help right away. She would be available to trouble shoot.

Christina: Thinks we need a policy. We did decide on Autonomy Zonal Forum.org.

We can change anytime we want to. How many opposed to website options A,B,C?

Kim: Do we want to do a redesign or stick with this. We have to talk about hosting.

Merle: Does design depend on hosting site. We decided we wanted to get away from C&P. Do we want an outside hosting company or Kim. Stay embedded in C&P.

Christina: Asked body who opposed to hosting or not? No response at this time.

Sherry: Do we change formats.

Kim: Change design. No limitations on server.

Steve: If we choose to accept Kim's hosting service at no charge, until we decide at a later time.

Kim: Charges vary to her clients.

Steve: Says C&P's regional host person never charges...except \$1.00

Christina: asked do we have exceptions to Kim hosting web?

Merle: Should Kim host?

Eddie: Gets where Merle is coming from. Is a graphic designer. Never charges NA a penny. Boils down to interpretation.

Brandon: Does a lot of free stuff for NA. Only conflict he sees is maybe too much work on his end! Responsible thing to do is ask for help if it gets overwhelming. Zoe: Asked Kim her credentials for hosting.

Kim: 15 years web hosting. Gives 24/7 to service. Has phone set up to detect problems. Knows when because of automatic notifications. Has a sponsor, reputable.

Zoe: Asked if approved would Kim have duties and responsibilities (which need to be formulated)

Kim: Secretary has at her hands all the information that Kim has should someone else need it.

Christina: Any objections to Kim's server hosting? None. Kim will host website.

Christina: Do we want A.B. or C?

Kim: Wants to drop map and come back in six months. We need to ask Michael to drop the site he is currently hosting.

\*\*Body agreed to ask Michael to drop his web hosting for the Zonal.

Steve: Wants to get something running.

Brandon: Kim offering a free idea; just to bring us up to speed. Thinks she should create a site for our discussion.

Christina: We can still have operable web site.

Kim: We can go with A or Barbara: Can't go with C without more effort. Will work around.

Merle: Asked if HTML, CMS, WordPress are all usable.

Sherry: Has done HTML – only updates not designs. Thinks HTML is best.

Christina: Are we okay with going ahead to get something up and going? Kim will work on design for next six months. Hearing no objections.

Merle: Are we all agreeing we don't want CMS?

Kim: Can put anything in – Option C without text. Can add all links that go to NA information.

\*\*Sherry to send Kim links to all information.

Steve: Just wants to get site up.

Christina: Asked what map we want A or B. C is the same as Barbara: Steve: We are the Autonomy Zone not focused on World information.

Christina: Anymore input?

Eddie: Asthetically we need the most attractive; sort of like where your eye is led on the site.

Christina: Therapeutic Group left Mountaineer Region.

\*\*Kim to remove Therapeutic Group from current website.

Christina: In favor of map A is 8 people. One person in favor of map B.

Kim: Stated we want to move away from CMS. She will design a site to be reviewed and given input to for January's zonal. Will change color.

Christina: In a phone conversation will be discuss links.

Merle: Thinks we need to acknowledge C&P region for use of their website for all these years.

\*\*Donna to do draft of thank you letters to C&P region and Board of Directors. Cheryl will deliver letters after approval.

Christina: Are we leaving Resolution A on website? No objections. It stays. Sherry: Has more information on Resolution A in a PowerPoint that would be

helpful.

Christina: On phone call we will talk about if to keep Resolution A.

Next on Agenda:

Steve: Suggested for everyone to give their research findings to Merle and regional minutes.

Merle: Is this from their website or did people visit other zones? Thinks that we failed to develop a set of questions that are consistent.

Zoe: We had a general direction from our inventory. Thinks we need to move forward. Stated at the WSC the question was asked 'what's the function of zones?'. It was shared to create a zonal forum that is unique. Stated this was discussed at least in two cycles of the WSC.

Christina: Do we actually have a vision statement? One thing we lack we don't have policy/vision/mission statements. Are we a discussion body or an action body?

Steve: Thinks if we don't get our zone together we're going to be lost. One big problem: we call our zones, zones. A zone is different around the world.

Christina: Mentioned that we we're kind of "funneled" – our research was to discover what zones do.

Zoe: Perhaps we're facing a possible dissolving our zone if we don't change our biannual meetings.

Steve: Discussed more Resolution A and board stuff. Thinks US has been left behind. We lost outreach, H&I, and PI. We don't do these events.

Cheryl: Does not feel like people were manipulated at WSC. Thinks we should bring WSC members in to discuss issues.

Sherry: Gave another perspective regarding round tables at WSC. WSC is getting information from RD's on how to proceed with what a zonal's purpose is to be. Christina: Wants to know how to spend the rest of the day. Work on a plan or go over what we learned at WSC? Where do we want to see the zonal go?

Steve: Presented a flyer about a multi-zonal service symposium in St. Louis, Missouri on September 26-28, 2014.

After Lunch: Start to formulate an actual plan for our zone.

Christina: (after lunch) led us in opening the meeting again with the Serenity Prayer.

Christina: Reviewed our 2013 zonal inventory and reminded the body of the

following: learning days and workshops; improved communications; coordination with outside entities; and fellowship development.

Barbara: Could we do a calendar to help us coordinate events?

Christina: We don't have a structure to make this happen.

Merle: Two calls between AZF's – the way it's structured whoever hosts the next zonal coordinates the phone conferences. Even though we have a plan; we're falling short.

Kim: Once we move forward we could have discussion boards and post our calendar.

Sherry: Suggested making a timeline on an Excel spreadsheet.

Steve: Would like to have timeline on our website; we could plan our phone calls; be prepared. Each member would sign in and post questions and replies.

Merle: Do a discussion board.

Kim: We can do a discussion board and make it password protected.

Zoe: Using online spreadsheet maybe webinar. Visited Southern forum and heard discussion on what venue they use for discussions.

Sherry: Thinks conference calls were fine but we didn't have a firm agenda.

Webinars may be too expensive.

Kim: CARNA has done webinars. How many people do you want to have involved? You can have a document in front of you.

Steve: Thinks we could use the discussion board for preparation.

Kim: Could be working on our duties and responsibilities of any developed zonal positions in the future.

Christina: We have no structure now. Other zones have positions.

John: We should consider vision statement/mission statement. We're not headed in a logical direction.

## Christina: Teleconference call will be Monday, October 20, 2014 @ 9:30pm

Kim: Will set up a discussion board with a password.

Merle: Reminded us that the next conference call should be hosted by next hosting region for the zonal.

John: Thinks we need to see it and piece it together as we go along.

Christina: What we want to accomplish. Breakout sessions seem to work well.

Sherry: Get into the how, should be what is in our vision statement.

Christina: In our inventory: more learning days; reduce redundancy of services;

fellowship development. What are we doing? Asked for a timeline.

Sherry: Wants a drop down list in the calendar.

Cheryl: Maybe asking for help like Christina suggested.

Merle: How about inviting someone who has helped establish a zonal. We need to focus on a) finalize AZF mission statement, b) our priorities, and c) discuss our next conference call.

Eddie: Will create our inventory on posters.

Kim: Also could use a projector.

Steve: Did we get any feedback from the WVA Convention learning and training day? \*\*Steve offered to arrange for a two hour slot at the next C&P convention for a zonal learning/training day discussion.

Christina: Do we want to finish the what of the website today? Work on our mission/vision statements?

Kim: Map, information about zonal; archives; Resolution A, mobile on current site, - what we want – calendar.

\*\*\*Vision statement is where you want to be. Mission statement is how you get there.\*\*

Sherry: Look at other zones vision and mission statements.

Merle: Having an events calendar

Christina: Region wide events. Mentioned discussion of links. One link to NA.org. A resource link to go to our literature; for professionals; locate meetings; Is NA for Me?

Kim: Who does this website serve?

\*\*REGIONS\*\*

Eddie: Link to find a meeting.

Kim: Training our RD's. Under resource link: Link to local resources, a subscribe to option for members to know when the site has been updated.

\*\*Topic of conference call: Vision and Mission statement.

Merle: Can we have multiple pages on the bulletin board? Is willing to go to

Freestate. Topic: Talk about zonal history and the direction we're going in and why we are going there.

Sherry: Thinks that all RD's should try to attend all regional conventions to become a face for the zonal.

Christina: Learning/training day. What if we devoted an hour to a topic that helps zonal members expand their knowledge.

Merle: Our next agenda topics:

- Finalize AZF vision/mission statement (this to be worked on during conference call)
- Prioritize a list of goals
- Timeline for what we want to accomplish
- Discuss next conference call
- Send reports to secretary as they're not read at meetings

Steve: Wants to know if those who are not RD's may speak?

Kim: When predecessors' don't give new people a chance to speak.

Iohn: Whoever is the facilitator gives priority to RD's on discussions.

Sherry: Never has been a 'no' you can't speak at zonal except at January before conference autonomy zone.
