Zonal Reports

Central Atlantic:

The Central Atlantic Region has 17 Areas and 1 Metro that covers parts of Maryland, North Carolina, Virginia, and West Virginia. Our meetings are virtual, Hybrid and In Person throughout the Region. Our Regional Service Conference meets 6 times a year on even numbered months and our Regional Subcommittees meet on the odd months 6 times a year. Both are still meeting on the virtual platform.

Our 39th Annual Regional Convention was held on January 21st – 23rd, 2022 in Harrisonburg, VA, hosted by the SheVana Area. It was in-person and nearly 500 members attended. The Beach Area won the bid for 40th AVCNA, which will be held in Virginia Beach in January 2023.

Regional Subcommittee activities include the following: Public Relations has started PSAs carrying the NA message on late night TV. They continue to give updates for our YAP service. H&I has a new Chairperson Carol M, who unfortunately ha not showed up since being elected. Several Regional motions were referred to the Policy Subcommittee, which hashed out the motion language. These motions have now been sent back to groups.

Open Positions currently include: Speaker Jam Chair, Vice Treasurer, and Vice Chair. The Delegate team have announced two CAR/CAT workshops, on February 20th and March 5th. Both will be virtual. We are opening voting on the CAR/CAT in the Region, and members may vote three ways: electronically through a ballot on Surveymonkey, by paper ballot, or in person at the GSR Assembly.

Finally, the Delegate Team is preparing for the GSR Assembly on April 16th. In the morning we will hold in person voting for the ICC CAR/CAT. Regional Trusted Servants will give brief reports to the GSRs, as required by our policy. In the afternoon we plan to hold workshops on Encouraging Service and Mentorship in Service. These topics emerged as Action Plans from our Regional Planning process.

It is an exciting and busy time in NA service in the Central Atlantic! YIS.

Eastern PA:

Shawn officially stepped down as the RD at our August Regional Meeting. There was also a motion put forth to the three areas to disband as a region. The areas voted to disband, and we are currently working at finalizing our financial obligations and to maintain communication and a connection for addicts seeking recovery. At this point Twin Rivers has joined the MidAtlantic Region. Pure and Simple area and Bucks area have not made a decision as to which Region they will go to.

Freestate:

The Freestate Region consists of 10 areas covering Maryland, Delaware, and Virginia. Many meetings and service bodies are meeting in person, hybrid, and virtually. Some of our areas are having more success than other re-opening and filling positions. The Freestate Regional Committee has been meeting hybrid. Our meeting place is open with restrictions. We meet the second Saturday of the month at the Service Center and via Zoom starting at 11am.

The region will be holding elections in August and all positions are available. Many of the subcommittee chair positions are open as are some of our executive body alternate positions. Vacancies include H&I Chair, and Special Events Chair. Three of our regions don't have a RCM II. NAWS recently sent a survey out to members regarding the virtual, hybrid, in-person nature of future WSC. The FSR did not like the idea of hybrid but did favor moving in the virtual direction. As far as moving the conference to a 3-year cycle instead of a two year cycle our Region was clear-they like the 2-year cycle. RCMs also agreed that WSC should pay for RD's and the FSR should pay for the AD to attend the conference.

The FSR has been discussing using CBDM to conduct Regional Business. The AZF provided a workshop yesterday on CBDM in the hopes that members would gain a better understanding of how it works. The FSR will decide whether to try the model.

The FSR put forward a motion to be placed in the CAR.

Motion:

To direct NA World Services to remove the Hospitals and Institutions Handbook from the inventory Intent: To remove an outdated service manual from WSO inventory Rationale:

The H&I handbook has not been updated since the 1980's and with our current literature update process, will never be prioritized high enough. We believe a better approach would be to update the Public Relations Handbook Chapter 6 (Criminal Justice) resource section and H&I Basics with more

information relevant to current practices and methods for carrying our message that could include using virtual platforms and tools. We believe this will better serve our trusted servants involved in H&I service by providing more current and better tools

The motion has been received by the WSO. We are awaiting a written response from the World Board.

UPDATE ON The Motion: Covid has caused the WSC to be moved to 2023. We may bring this motion up then.

FSRCNA was held 11/26-28 in person at the BWI Marriott. The FSR had a 1 hour and 15-minute workshop on Saturday afternoon. It was a success. FSRCNA was very successful. The profits above expenses and holding seed money for next time were approximately \$20,000. Donations of \$10,000 each were made to the NAWS and the Service Center.

The delegate team attended the Multiple –Zonal Service Symposium Aug 27-29 in San Antonio.

Many of the ideas for our current AZF came from that symposium. CBDM workshops and breakout rooms to name a few.

The delegate team will attend MARLCNA next weekend.

The Freestate Region hosted the current AZF.
