Regional Reports

Central Atlantic Region

The Central Atlantic Region of NA consists of 17 areas and has a little over 600 meetings in Virginia, West Virginia, Maryland, and North Carolina. Our Regional Service continues to meet 6 times a year (even months). Four of those times we meet in a centralized location in Charlottesville, Virginia and the other two times - for our April and October 2 day events - we rotate throughout our very large region, which includes all of Virginia and snippets of West Virginia, Maryland, Pennsylvania, and North Carolina. All of our sub-committees are fully functional and meeting regularly on the off months from when our RSC meets (odd months) both in person and via Zoom Teleconference. Our next RSC is scheduled for August 18th, 2018 from noon to 5pm at UVA Medical Center, 1215 Lee St., Charlottesville, Va.

Our Team will be changing prior to our meeting in January. Dee and Randy will be nominated and I expect they will be voted in as the new RD and RDA at our December RSC. I have loved serving with you all that the AZF and am quite melancholy that my time here is finished.

We have an "up and running" *Inmate Step Writing* subcommittee, which is part of our H&I Subcommitee. We continue to struggle with filling all the available positions needed to support this effort (ISW Chair, ISW Vice Chair and ISW Coordinating Secretary).

Our Public Relations Subcommittee remains focused on improving our regional website, updating our Phone Line, and carrying the message to the public. We have the BMLT active on our website and a couple of the areas within our region also have it on theirs. They were able to again set up a table at the annual Summer Institute of Addiction Studies Workshop in Williamsburg, VA this past July

We received two cases of books from the East Coast Convention to be distributed to our Region's Jails and Institutions since my last report.

In April Randy and I facilitated our annual GSR Workshop in and it was very well attended. Members of our executive committee and subcommittee chairs submitted their annual written reports and we were also able to benefit from some verbal reports from our trusted servants. A delicious lunch was provided to all who participated. At one count there were over 40 members in attendance, and the afternoon IDT workshop "Welcoming All Members" was a wonderful success. The feedback from the small group discussion was collected and was submitted to NAWS through worldboard@na.org

The Central Atlantic Region's Delegate team plans to have round table workshops at our October 2-day on our 2 new IDT's: Attracting members to service and Carrying the NA message and making NA attractive.

Another hugely successful BRANA campout was held on July 20-22, 2018. BRANA 37 (Blue Ridge Area of Narcotics Anonymous) was held at Natural Chimneys Campground in Mt. Solon, VA. Dee and I attended the first CP Webinar of this cycle on July 21, 2018. We felt it was very good to meet via Zoom and contribute to the planning of our IDT Workshops.

The things we struggle with within our region seem to remain consistent. We struggle with motivating addicts to take commitments. There has been limited discussion regarding DRT/MAT issues

The C&P Region meets every other month, our next RSC meeting will be hosted by Norvana Area, Saturday, August 11, 2018–10:00 AM - 6:00 PM, **Location:** Fairlington Presbyterian Church, Alexandria, Va. All RSC positions were up for nomination at the June 2018 RSC. Election to be done at the August 2018 RSC.

ISSUES AND CONCERNS IN YOUR REGION:

Convention Relocation Feasibility Ad-Hoc, met on June 2. Assignments to research venues: Dulles Corridor, Univ. of MD; DC Amory; Showplace Arena. Search is ongoing. They are still collecting data for prices. One venue contact has requested what are the complete C&P convention requirements; Ad Hoc group to talk with Convention Oversight Committee and review Convention Policy before they complete the request form.

As of April 18, 2018, the Restructure of the C&P Region and the Board of Directors is official, and the name change has taken place. The new name is now: Chesapeake and Potomac region of Narcotics Anonymous, Inc. Papers are filed and Stamped in the State of Maryland Department of Assessments & Taxation. Its Official. The intent is to modify the relationship between the RSC and CPRC, Inc., 1) legal accountability; 2) allows for the RSC to comply with federal and state laws. CPRSC and CPRC, Inc. are now in the transition phase to seat the new Board of Directors.

Report July 28, 2018

In PR, we have been discussing different means to get out the word to addicts in our region. Our focus has been on benches, either in parks or bus stops, and if any other region has experience with this, please let us know what you have uncovered. We are also considering "Adopt a Highway" as a vehicle.

We are planning to do an environmental scan for our region sometime after our October RSC.

Free State Report Autonomy Zonal Forum July 2018

Date: July 28, 2018

Activities:

The following are brief updates and highlights of activities in our region.

• Free State Convention

As reported previously, we will not be having a convention this year due to last year's event not being financially successful with the biggest loss coming from the breakfast banquet. There is also a lack of support on the convention board with 8 seats out of 15 open. A decision was made to hold the convention every other year. There was discussion of providing the convention body with some help financially but we want to address the problems first and find some solutions to helping make the event fully self-supporting, better attended, attracting board members and more support from the areas. It has been generally agreed that helping with fundraisers is the prudent approach right now and are discussing fundraising ideas and types. We are planning on having some type of event this year during the time the convention would have been held in November.

• Public Relations

A draft of a PR work plan has been developed. It includes revitalizing the subcommittee, providing better support for area subcommittees, more collaboration with the C&P region in ongoing statewide PR and planning of joint activities (i.e. PR Week 2019) as well as transitioning oversight of the website under the auspices of the PR subcommittee. That process is under way. We are working with the current website administrator and other NA members with experience with websites, WordPress and BMLT and recruiting local members. The idea is to create a Web team within the subcommittee and to have more than one person involved for redundancy and to foster continuity. We have developed a transition plan that includes evaluation of the current website infrastructure and processes, defining the objective and mission of the site, moving to WordPress and purchasing a new hosting server for building and testing a new site. Some of the short-term and long-term goals identified are enhanced navigation capabilities, centralization of updating/printing of meeting schedules to improve reliability, timeliness and consistency, developing a statewide meeting list and be in position to take advantage of emerging technology.

Budget Ad hoc

We have created an ad hoc to develop a budget and a more effective budgeting process for the RSC and recommend changes in financial policy such as having the RSC pay for the phoneline instead of areas earmarking funds. The objective is to improve on budgetary planning, efficiencies, accountability and tracking of income and expenses

• Regional Delegate Team

Trish and I are discussing ways to facilitate discussion in our region of the Issue Discussion Topics. Within the RSC, we have also been discussing sending our delegate team to different events throughout the service cycle to take advantage of opportunities for the exchange of experience and best practices between members of NA service. Our regional delegate team can benefit from this and add value to our service efforts by bringing back what they learned and sharing with us. We are planning on sending them to the Multi Zonal Service Symposium (MZSSNA III) to be held November 2-4, 2018 in Omaha, Nebraska.

RSC Miscellaneous

Elections scheduled for next month; decision made to hold off on automatic donation to NAWS until we gathered more information regarding potential upcoming regional learning days, workshops and possible financial support to the convention body. Upcoming events:

Feels existing AZF has no value have taken "NA's" and retrofit it for AZF. Suggested a Mission and Purpose statement not a vision statement.

- Input: Food and hotel in a budget
- Input: We can continue to do what we've been doing as far as secretary do for facilitator. Region could also get a facilitator too. Doesn't think it's necessary nor should they be funded.
- Input: better to have some continuity. Get to know one another.
- Input: Background as professional facilitator.
- Input: Need for separate budgets
- Input: agrees on a facilitator. Secretary provided by hosting region
- Input: Not deciding today.
- Input: Budget for two rooms. Could match up delegates like WSC share rooms with secretary and facilitator.
- Input: we should vote on now and give info to our regions. Make a decision now.

- Input: With all the regions here why not use conventions and other ways to create funding.
- Input: Create Tentative financial impact
- Input: No straw poll has been taken. Create steering committee to put together information. What about a treasurer? Who will handle money. Do a timeline for information finding to be completed.

From Delegates

- Input: Financial information- It would cost each region approximately \$124.00. Comparing to budget from CARNA who's budget is \$760.00/delegate/year.

- Decision Is anyone opposed to bring back to region a secretary/treasurer position and facilitator positions.

No Opposition
