Central Atlantic Region

The Central Atlantic Region of NA consists of 17 areas and has meetings in Virginia, West Virginia, Maryland, Pennsylvania and North Carolina.

Please welcome our new RDA2, Randy D., to his first Zonal meeting. Our RD, Kim A. is travelling today and is unable to attend.

The RD Team attended the Florida Service Symposium in March and was able to bring back some information on best practices in information technology and public relations. We are starting to workshop these items with the appropriate people in region, and hopefully will be able to incorporate these ideas in our Areas.

Our subcommittees have started to make use of Zoom Teleconferencing, which has allowed people to attend their meetings remotely. While in its early stages, the use of this technology looks promising in terms of garnering more support. It was decided by Region that for the time being we will still rotate the physical subcommittee meetings by quadrant to allow people to attend in person. The use of Zoom has also allowed us to reboot our Inmate Step Writing program, and the results so far look promising, with more people able to get involved.

Our two-day event in April was well attended, and the workshops were well received. We did a Planning Our Future presentation and the IDT on Maintaining an Atmosphere of Recovery.

The C&P Region meets every other month, our next RSC meeting will be hosted by Battlefield Area, Saturday, August 12, 2017 – 10:00 AM - 6:00 PM, **Location:** Saint Mark's United Methodist Church, 7803 Well Street, Manassas, VA. During the June 2017 RSC nominations were held for all positions, except the RD and RDA, elections will take place at the August RSC to begin at the close of the August RSC for September 2017.

ISSUES AND CONCERNS IN YOUR REGION:

Motion to donate up to \$20.000 to the FreeState Service Center to assist in ensuring a literature surplus was sent to groups and approved. Waiting for final Convention numbers to be presented at this July Board of Directors meeting.

February 18, 2017, motion was sent to groups to restructure the existing C&P Regional Convention, Inc so that the C&P RSC would become the primary organization under the 501(c)(3) nonprofit status; and that the current Board of Directors would become the Convention Oversight Committee, a subcommittee of the restructured organization. Motion was approved at the April 2017 RSC, with a group tally group: 144 (Yes); 33 (No) and 33 (Abstain). The intent is to modify the relationship between the RSC and CPRC, Inc., 1) legal accountability; 2) allows for the RSC to comply with federal and state laws. CPRSC and CPRC, Inc. are now in the transition phase, where meeting with the attorney allows for updating of the Articles of Incorporation. More to follow.

We have a robust schedule of Learning Days, Service Workshops, etc. Something that is new is we are exploring a Mentorship Program and seeing how and if that would be something that would benefit the Region. We will ask for experience on this program at the Zone. We have a new RDA Clarence, someone a lot of you know already.

Mountaineer Region

The Mountaineer Region consists of 11 areas with about 150 meetings per week. Our RSC meets quarterly to do business and once in March to do a regional inventory\planning session or CAR\CAT workshop in alternating years. We have been using consensus based decision making for over a decade. We have two conventions per year, one in the spring and one in the fall.

Our conventions are our primary source of funding to our regional services accounting for about 80% of income and donations at around 20%. Our convention subcommittee exists entirely within our regional service committee and operates out of the regional bank account. Over the last year we spent over \$10,000 on PR and sent \$3000 to NAWS. Most of our PR spending fell into two areas- our phoneline and billboards. We combined our PR, Phoneline, Website, and H&I services into one PR subcommittee a few years ago, and it seems to be working well for us.

We have had some discussion about the future of the WSC, and our region does not support a move to zonal

seating but is open to other changes such as a planning conference and a 3 year cycle. Our delegate team has participated in the NAWS web meetings, and we are following and taking part in the discussions on the conference participants bulletin board as well as discussions on Facebook. We will be asking our region to pay for the RD to attend the WSC rather than accept NAWS funding. We attended MARLCNA this year but have since amended our policy so that we could attend a different event in years when there is no WSC.

Overall the Mountaineer Region is doing well. We are seeing growth in the meetings. We are financially stable. We hope to expand our PR efforts in the future especially with the ongoing opioid crisis. In Loving Service, Cooper B, RD and Ryan S, RDA

Notes on Today's Agenda:

- Motion 11 -- Shared thoughts on whether we WANT to have a Zonal representative at the WSC; ideas shared included:
 - that Zonal representation is going in the wrong direction and sends a misleading message to the WSC,
 - o a note that the zonal rep would not be a seated position,
 - o sending a zonal rep might allow the Eastern PA RD to have a voice as a zonal rep
 - o concerned about WSC moving in a direction that would cause the Regions to lose their voice
 - o a more clear zonal vision might enable a better conscience
 - funding
 - o should we consider doing a favor for Eastern PA and choose their RD to be Autonomy's Zonal Rep just so that their RD can have a voice. Eastern PA is going to fund their travel no matter the Zone's decision. Several members support this as a sign of unity within the Zone.
 - o Taking advantage of the offer to send a zonal rep allows an unseated Region to learn and grow
 - How would the zone arrive at a conscience to send with the zonal rep? At this time they can't vote, but they can give opinions in the discussion
 - Suggestion that each RD take to their regions a proposal to let EPARNA send their RD as a Zonal representative;
- Revisit the inventory
 - Moved to a future date
- Discuss proposal changes for WS
 - First webinar:
 - Changes proposed for the Old Business sessions may help the jumping back and forth between consensus based and parliamentary procedure
 - Changes in new business distracted by a skunk in my trashcan
 - Inclusivity mentor and train members; what does this have to do with changes?
 - Second webinar
 - RDs expressed feeling cornered and driven to choose between choices that no one wanted to start with as the WSC chose the solutions to be discussed without input from the Regions
 - A motion was rejected in the CAR, and the board brought it back for discussion again in this webinar; some recognition that this is the board's job – to nudge and retest the waters. We need some kind of solution for the WSC's growth and seating
 - The forced discussion allowed the RDs to hear some of the pros of something they are totally against; others thought of that as manipulation
 - Resolution A

- Discussion of the "problem" of the size of the WSC and addicts' fear of change
- Desire to have the ideas come from the groups up through the areas and regions not down from the board
- Openmindness
- Us vs. them
- Discuss some of the best practices for the workload of the RDs
 - How do regions (specifically RDs) handle workload? ideas for discussion (besides IDTs?) workshops?
 - Some delegates are struggling how to justify the Zone and their participation in it. This topic is an effort to renew a value in zones
 - Re: engaging members: integrate speakers presenting about service opportunities with the speakers and food at a speaker jam; do IDTs with the GSRs; read the feed on the bulletin boards; integrate with learning days and all events adding "a regional track"
 - o RE: IDTs: IDTs as part of a CAR workshop day
 - Visit the areas and present ideas and do straw polls
 - Current amount of information flowing through RDs has grown tremendously. How to manage
 the dissemination of this information: propose topics and ask areas for input and questions;
 part of the challenge is to present the relevant information in a way that is interesting to the
 regional members; RDs have to keep up on a daily basis or will get behind.
 - o Volume of information sources to check has grown as well
 - o Delegates vented about the volume of information from a myriad of sources
 - Suggestion to limit the discussion at WSC due to technology available; trusted servant vs. bound by regional conscience
 - Educate the members that a delegate/RCMs job is to take their conscience to the service bodies; they some time they think that is "your job"
 - Retire from your full time paying job (sic)
 - Challenge to present what is RELEVANT; because then we get attendance, interest and input;
 present the impact of the topic on the individual member or group
 - Encourage sponsees to engage in service
 - Share the message of service wherever we go
 - Had difficulty leaving the topic despite the facilitator's effort to move on to planning an event and open forum
 - Summary that this type of discussion (best practices for RDs) is getting the best bang for the buck; much more productive than talking about the web site, for instance

 - o Ran out of time
